System76 Superfan 3 Official Contest Rules

1. WHERE TO ENTER

Two ways to enter:

- **1.1 Social Media Entry:** Use #superfan3contest on Twitter, Instagram, or Facebook to enter. In your post, tell us why you should win a trip to System76 headquarters or show us what you've made using open source software. Per Facebook regulations, Facebook submissions must be posted directly on the System76 Facebook wall (https://www.facebook.com/system76/) in order to be counted as an entry. Each individual post submitted via Twitter, Instagram or Facebook must include the hashtag #superfan3contest to count as an entry. If you do not have a social media account, please refer to section 1.2.
- **1.2 Email Entry:** For those who do not have a social media account or do not wish to use their account for this contest, you can submit your entry via email to press@system76.com. This submission does not require you to have a social media account.

2. HOW TO ENTER

- **2.1** Enter via email (press@system76.com) or via Twitter, Instagram, or System76's Facebook wall. Entries via social media must tag your entry with #superfan3contest. Submit only one entry per submission. However, unlimited entries can be submitted per person. You may submit any creation you've made using open source software from any time. Past winners please refer to Section 2.2. Here are some examples of what you can submit for entry:

- Mailed submissions will not be reviewed.

You have until 11:59 p.m. MST October 4, 2019 to submit your entry.

2.2. Past winners are not eligible to apply.

3. ELIGIBILITY

You must be 18 years or older and a resident of the contiguous United States to qualify. ONLY INDIVIDUALS CAN APPLY. Employees and immediate family members of System76 staff are not qualified to enter. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

In compliance with FCC regulations, all submissions posted in social media must use the hashtag **Superfan3Contest** (#superfan3contest). Entrants may also enter via email

by sending their submission to press@system76.com. Submissions must be your own property in order to be eligible for a winning entry.

4. CONTEST PERIOD

You are allowed unlimited submissions over the duration of the contest. Each submission will count as one entry. The contest commences on September 13, 2019 and ends at 11:59 p.m. MST October 4, 2019. Entries that are submitted after October 4th will not be considered. Contestants may enter by using any of the following platforms:

5. WINNER SELECTION

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. Purchase of product does not enhance your chances of winning. All entries must be your own property. Up to ten people can win. The odds of winning are dependent upon the number of eligible entries we receive.

Winners will be flown to System76 headquarters in Denver, CO. You may share content created from any time (there is no expiration date). (Previous Superfan winners are not eligible to win.) Selection criteria includes but is not limited to:

- Creative skills such as writing, video, photography, design, etc.
- Originality*
- Post engagement**

*Work is your own. Article, reviews, blogs containing less than 25% quotes and no plagiarism. All graphics, videos and other artwork are your own creations. (Stock photography used in artwork is approved for use - but not as standalone submission pieces.)

**Friends sharing, liking, or voting for your posts and/or submissions that contain social engagement may help your chances of winning.

6. WINNER NOTIFICATION

Up to ten winners will be notified via social media private messaging or email on October 8th. Winners will have 24 hours to confirm acceptance. If a winner does not respond within 24 hours, an alternate winner will be selected.

For those contestants that enter via social media, platform limitations exist (such as the inability to receive messages from non-followers in Twitter). We recommend that contestants follow us so that we can contact you directly via your social media account and notify you of your winnings.

Once winners confirm acceptance, we will publicly submit a winners' list via System76 social media pages on October 8th. The winners will be required to sign a release and affidavit of eligibility. Winners must also provide information needed to secure the hotel and flights, such as legal name and date of birth. Winners will have three days to return their affidavit of eligibility.
